

Integration of Specific Local Search Methods in Metaheuristic Algorithms for Optimizing the Feature Selection Process: A Survey

Abstract

Metaheuristic algorithms have proven to be quite effective at solving global optimization issues, particularly feature selection difficulties. This class of algorithms often uses a specialized local search technique as an inner component or as a post-processing mechanism to improve the performance of their search process. This paper presents a comprehensive survey of the use of local search methods integrated into metaheuristic algorithms for optimizing the feature selection process. Based on the manner of operation, the local search methods examined in this study were classed as one-way or two-way. In addition, practical suggestions were also discussed to point out possible future directions.

Keywords—*Metaheuristic Algorithms; Local Search Methods; Trajectory methods; Combinatorial Optimization; Feature Selection*

1. Introduction

Optimization is the process of finding the optimal option from among a variety of alternatives. It is primarily employed in situations where decisions must be made in a specific set of circumstances (Sun et al., 2020). Optimization problems emanate from various fields and disciplines such as engineering design, agricultural services, manufacturing systems, economics, etc. Several studies have been conducted to solve optimization challenges by introducing new approaches or improving existing ones. Optimization problems come in different types but are majorly divided into continuous and discrete or combinatorial optimization (Vesselinova et al., 2020).

Combinatorial optimization involves selecting the most optimal subset of variables from a set of finite variables to minimize or maximize the objective function, which frequently entails not just single but several objectives (Ramos-figueroa et al., 2020). Combinatorial optimization has piqued the interest of scientists in fields as diverse as artificial intelligence, and operations research among others. Many of these issues are simple to define, but the process of solving them is quite difficult and complex (Ramos-figueroa et al., 2020). Such types of combinatorial optimization problems have been categorized as NP-hard problems (Vesselinova et al., 2020). Examples include the traveling salesman problem, knapsack problems, decision subset sum problem, and feature selection among others. However, in this paper, we solely discuss feature selection as a combinatorial optimization problem involves the selection of the most informative features from the total available features. For example, a dataset "A" with a total of "n" features, selects a feature subset B consisting of "m" relevant features, where m < n and $B \subset A$ (Xue et al., 2013).

Several authors have categorized FS into three categories, namely the filter, wrapper, and embedded techniques (Adamu et al., 2021; Chaudhuri & Sahu, 2021; Huda & Banka, 2020). The filter approach assesses features using statistical information, the wrapper method evaluates the goodness of the selected feature subset using a learning algorithm (classifier), and the embedding method incorporates the benefits of both the filter and wrapper methods (Alzaqebah et al., 2020; Chaudhuri & Sahu, 2021; Huda & Banka, 2020; Tubishat et al., 2021). "Fig. 1" presents the general taxonomy of the FS methods.




Fig. 1. General taxonomy of the feature selection method

Several studies on optimizing the FS process have been conducted, beginning with exhaustive, heuristic, and metaheuristic methodologies (Chaudhuri & Sahu, 2021). Exhaustive and heuristic approaches are regarded as impractical, computationally inefficient, and still stuck in local optima (Huda & Banka, 2020; Mafarja et al., 2020). As a result, metaheuristics methodologies were created to improve the efficiency of heuristic approaches (Sarhani et al., 2018).

Metaheuristic Algorithms (MAs) are based on global search theory and are designed to address the shortcomings of exhaustive and heuristic approaches (Mafarja et al., 2020). MAs such as the Particle Swarm Optimization (PSO) (Kennedy & Eberhart, 1995), Salp Swarm Optimization (SSA) (Mirjalili et al., 2017), Genetic Algorithm (GA) (Holland, 1984), Moth Flame Algorithm (MFA) (Mirjalili, 2015b), Spotted Hyena Optimization (SHO) (Dhiman & Kumar, 2017), Whale Optimization Algorithm (WOA) (Mirjalili & Lewis, 2016), Harmony Search Algorithm (HSA) (Geem et al., 2001), Dragonfly Algorithm (DA) (Mirjalili, 2016), Coral Reef Optimization (CRO) (Salcedo-Sanz et al., 2013), Water Cycle Algorithm (WCA) (Eskandar et al., 2012), Ant Lion Optimization (ALO) (Mirjalili, 2015a), Clonal Selection Algorithm (CSA) (Castro & Zuben, 2002), Sailfish Optimization (SFO) (Shadravan et al., 2019), Harris Hawks Optimization (HHO) (Asghar et al., 2019), Ant Colony Optimization (ACO) (Dorigo & Stützle, 1999), Bat Algorithm (BA) (Yang, 2010), and Symbiotic Organisms Search (SOS) (Cheng & Prayogo, 2014) are some of the most used in solving FS problems available in the literature.

Because of the recognized issue with these MAs' exploitation phase, which causes local optima stagnation, the hybridization of these algorithms with specific local search algorithms such as the Simulated Annealing (SA) (Kirkpatrick et al., 1983), the Variable neighborhood search (VNS) (Hansen & Mladenović, 2005) among others have been studied (Ghosh et al., 2020). These local search algorithms are metaheuristics in and of themselves, but they are categorized as a trajectory or local search techniques since they deal with a single solution rather than a population of possible solutions like population-based metaheuristics (Chantar et al., 2021).



The main focus of our survey study is on integrating population-based MA with these local search algorithms to solve the FS process. To the best of our knowledge, there has been no work of this nature. However, Blot et al., (2018) presented a similar work but focuses on multi-objective combinatorial optimization not restricted to only feature selection problems. Other survey works carried out in a similar context to the proposed topic can be found in (Wang, 2019). According to Xue et al., (2016), works on MAs application for FS problems started around the early 90s, becoming most popular in 2007. As a result, our research solely covers works published between 2000 and 2021. Our goal is to provide researchers with a comprehensive survey of the state-of-the-art works on the subject matter, as well as a discussion of potential future work, which we believe will be of great benefit to prospective and contemporaneous researchers who wish to conduct a more in-depth investigation of the topic.

The remainder of the paper is laid out as follows: Section II has a brief introduction to key concepts on the issue; Section III contains a study of works in the literature arranged based on the type of local search method incorporated; Section IV presents the discussion on works in literature as well as recommendations for future works. Finally, section V contains the conclusion.

2. Preliminaries

In this section, we present the basic ideas to help understand the proposed topic. First, a brief explanation of population-based metaheuristic algorithms is presented, followed by a general overview of local search algorithms in the literature.

2.1 Population-Based Metaheuristic Algorithms

The phrase "metaheuristics" can be broken down into "meta," which means "beyond," and "heuristics," which means "to seek or direct a study or examination" (Sarhani et al., 2018). These metaheuristic algorithms provide highquality solutions in a fraction of the time it takes to use typical traditional optimization techniques. Aside from population-based and single-point search (trajectory), Ghazali, (2009) classified MAs into several other categories based on selected characteristics i.e., nature-inspired against non-nature inspired, dynamic against static objective function, memory usage against memory-less methods, swarm Intelligence inspired against evolutionary inspired, etc.

The key idea behind MAs is to maintain a balance between exploration and exploitation during the search process. During the exploration or diversification phase, they are expected to explore un-visited regions, while in the exploitation or intensification phase, focusing on already-visited regions is required (Chakrabarti et al., 2019).

2.2 Local Search Algorithms

In this section, we choose to categorize the local search algorithms into two according to their mode of operation:

- i. One-way Local Search and
- ii. Two-way Local Search or Trajectory methods

Note that the justification behind the classification is due to the exploitation-only nature of (i) and the explorationexploitation nature of (ii). The one-way LS is based solely on exploitation, that is, it makes local adjustments or perturbs a single solution until it improves. An example of LS methods in this class is the paired swap (Liao & Kuo, 2017), where the positions of two selected features in a solution are swapped to achieve a better result. The two-way LS, on the other hand, is based on both exploration and exploitation, which means that as a result of the changes made to the initial solution, several neighboring solutions are formed. The best among is then substituted and used as the new solution. An example is the Simulated Annealing.

2.2.1 One-way Local Search (exploitation only)

This category of local search algorithms operates in a most similar way to the mutation operator in the evolutionary genetic algorithm. It involves selecting one or more bits (features) in a solution and performing an operation mostly flipping or perturbance i.e., changing from 1 to 0 and vice versa (where '1' represents selected features and '0' for unselected features). The idea behind this is that, by flipping the bits, there is a possibility of de-selecting an irrelevant or redundant feature as well as a possibility of selecting a highly relevant feature. The presence of these irrelevant or redundant features causes a degradation in the classification performance (Alhamidi, 2020; Mafarja, 2019). Therefore, performing this perturbance provides room for possible improvement. Examples of local search algorithms in this category include the Sequential One Point Flipping (SOPF) (Ghosh et al., 2020), and NBChange (Alzaqebah et al., 2020) among others.

2.2.2 Two-way Local Search (exploration-exploitation)

This category of local search algorithms is also known as metaheuristics, single-point search, or trajectory methods (Ghazali, 2009). This class of local search algorithms also employs the exploration and exploitation phase (Al-betar, 2016). However, they operate by improving only a single solution (Chantar et al., 2021) unlike in the populationbased metaheuristic where a population of possible solutions is considered. The two-way local search algorithm begins operation on a single initial solution and gradually evolves it into a better solution using the neighborhood concept (Ghosh et al., 2019). They are either incorporated into the inner workings of the corresponding populationbased metaheuristic or used as a post-processing mechanism to refine the solution produced (Blot et al., 2018).

Hill Climbing (HC) is the most basic of all the two-way local search algorithms, and it serves as the foundation for the majority of the others (Al-betar, 2016). The HC does not involve any random component and is used to strengthen the exploitation abilities of population-based MAs (Blot et al., 2018). However, reports have been made that the HC is easily trapped in a local optimum (Blot et al., 2018). As a result of this constraint, multiple extensions to the classical HC have been developed, all to include various intelligent random operators (Al-betar, 2016). Some of the most common extensions of the HC include the Simulated Annealing (SA) (Kirkpatrick et al., 1983), the Tabu Search (TS) (Glover, 1986), the Greedy Randomized Adaptive Search Procedure (GRASP) (Feo et al., 1995), the Variable neighborhood search (VNS) (Hansen & Mladenović, 2005), the Guided Local Search (GLS) (Voudouris, 1998), the Iterated Local Search (ILS) (Kohlhardt et al., 1972), the Stochastic Local Search (SLS) (Hoos & Stützle, 2005) and their variants (Al-betar, 2016; Blot et al., 2018).

In general, both one-way and two-way local search algorithms have their advantages in the intensification/exploitation phase, since they can quickly find better solutions in the vicinity of the provided initial solution (Jia et al., 2019).

3. Existing works on the proposed topic

Following a thorough search on Google Scholar and Scopus, about 100 papers were collected with approximately 71 from Google Scholar and 29 from Scopus. Feature selection, metaheuristic algorithms, and local search are among the keywords used. However, only about 26 were deemed relevant for inclusion in the literature. The inclusion criteria restrict to only the integration of local search methods in population-based MAs for solving the FS problem from 2000 to 2021. These literary works are grouped into two parts based on the type of local search strategies employed and are sorted chronologically (from oldest to the most recent). Tables 1 and 2 present works on the topic that use one-way and two-way local search algorithms respectively, with each describing its proposed strategy, strengths, and weaknesses.

4. Discussion and Future Directions

It is observed from works in the literature presented that few out of the population-based MAs recorded a fair number of occurrences in the last two decades concerning the proposed topic. Table 3 presents the entire MAs reviewed in our literature based on the type of local search algorithm employed.

It is observed that only PSO, GA, SSA, and WOA recorded more than one occurrence in total over the last two decades, with GA attaining the highest. One possible reason for GA recording the highest occurrence is due to its adverse limitation in exploitation i.e., the mutation operator in GA responsible for the exploitation is insufficient. PSO also recorded a fairly high number of occurrences after GA. Although the PSOs exploitation phase has been described as noteworthy (Ghosh et al., 2020), works in the literature demonstrated that further strengthening it with specific local search algorithms yields better performance. Judging from table 3, it is clear that not much work has been done in hybridizing population-based MAs with one-way local search algorithms. Therefore, this should draw the attention of researchers in this field. Contrary to this, hybridizing population-based MAs with two-way local search algorithms has been commendable with HC, SA, VNS, SLS, and their variants being the most frequently used. However, in most research, higher computing costs as a result of hybridization and frequent calls to the local search have been identified as the major downsides. Although several researchers have suggested parallelization in MAs to share the workload among CPUs or GPUs, establishing specialized approaches for reducing high computing costs, such as developing a low-cost fitness evaluation strategy, will surely assist (Xue et al., 2016). Nonetheless, none of the hybridized techniques reviewed in the literature can be said to have solved the local optimum stagnation problem maximally. Therefore, there is still a need for more superior techniques to be developed.

In the future, researchers in this field should study the effectiveness of hybridizing these population-based MAs and the local search algorithms that have yet to be tried in the literature. However, an utmost investigation should be carried out when selecting a combination as not all of them complement each other. Additionally, other new and promising population-based MAs such as the Black Widow Optimization (BWO) (Hayyolalam et al., 2020) effectiveness with either of the local search algorithms should be investigated. Finally, more focus should be placed on developing unique local search methods that are properly adapted to the peculiarities of population-based methods that are frequency significantly.

5. Conclusion

The sole aim of this paper was to provide a comprehensive survey for the hybridization of population-based MAs with local search algorithms in solving feature selection problems. 17 population-based MAs that were hybridized with different specific local search algorithms to strengthen their exploitation capabilities were reviewed. The local search algorithms discussed in this paper were categorized into one-way and two-way local search algorithms based on their mode of operation. This survey reveals that different population-based MAs have over the years drawn the attention of several researchers to address feature selection problems. The most profound approaches are the PSO and GA which are among the oldest population-based MAs in literature. Concerning the local search methods, the HC, SA, SLS, VNS, and their variants were the most employed methods in the literature mostly because of their strength in exploitation thereby achieving optimum results.
