Analysis of Multi-Robot Cooperative Hunting Using Differential Game Technique

Abstract

This research presents two robots cooperative hunting behavior by the use of a differential game method. There are two pursuer robots that are trying to find and then surround another robot prey evader. The purpose of the game is for the two pursuer robots to find the evader simultaneously or when one of the robots finds the evader first it will wait for the other robot to cooperate with it within a specified period of time. We use differential game theory to formulate the problem with a system of an ordinary differential equation. The conditions for the termination of the game were given to be when one of the pursuers catch the evader and the other cooperate with it or when the two pursuers catch it simultaneously. We carefully analyzed all the mathematical equations developed using the ordinary differential equations for the game and present the sufficient conditions that can warrant the two pursuers to catch the evader either simultaneously or one first and then the other cooperates with the first one which will result in termination of the game. We also show mathematically that in the course of the game the robot prey evader tries to prolong the capture time, while the pursuer robots try to shorten the capture time.

1. Introduction

Multi-robot system is a system comprises of two or more robots acting together towards a desired goal. These kinds of systems are designed to act in such a way that the group's common objective is achieved and they are controlled by using cooperative control laws. In multi-agent system analysis modeling the cooperative behavior of the multi-robot is very critical (Schaal & Atkeson, 2010; Stone & Veloso, 2000). Two models are very important, the first one is a mathematical model that gives the computer-based simulations of all the necessary properties of the robot, and the other model which will gives all the necessary tools used in the analysis of multi-robot system and also used to maintain the most important aspects of the system in terms of operation. Up till now, most of the researchers are devoted to the area of implementing the real systems. Experiments and simulations are continuously used in a defined context to improve the control strategies until a defined task is accomplished successfully by the robot systems (Nehmzow, 2006). Generally speaking, the above methods can only be used to show that the robot systems can meets a given tasks. But the control laws may not be usually implemented successfully on platform of another robot or when the environmental conditions are changed. Considering the real systems, the manner of interactions between robots and its environment is still very difficult to understand. Similarly, mathematics methods cannot be used to model the behavior of robots' systems, and analyzing the behavior quantitatively is difficult (Varghese & McKee, 2009).

In real world, the abstract of the multi-robot systems can be found from the mathematical models of the cooperative behaviors of robots (Nighot et al., 2012). The research of the mathematical models gives better understanding of the robots' interaction with the environment (Helbing, 2010). There is many research work that try to model the cooperative behaviors of robot (Davoodi et al., 2021; Gualtieri et al., 2021; Parsa & Saadat, 2021;

Teslya et al., 2021). These models help in comprehending what is the main components in the behaviors of the system, and at the same time it can help us to improve our understanding in the properties which can emerge from the collective behaviors of the robot. A method that deals with control and perception in amidst of uncertainty is known as probabilistic robotics (Moulin-Frier & Oudeyer, 2013). Thrun, (2000) presented the use of probabilistic robotics method for programming robots, the method generally performs better in complex real-world applications than all the other approaches that neglect the uncertainty of the robot. Burgard et al., (2000) presented the use of the probabilistic method in case of coordinating multiple robots, in this method all the utilities for the target points as well as all the costs for reaching the target point were all put in to consideration. Fox et al. in Fox et al., (2000) presented an algorithm for the localization of mobile robots' collaboration. In their method they were able to use the Markov localization type-based sample in localizing the mobile robots at any given time.

Differential game is one of the most popular areas in applied mathematics and is still having more perspectives for researchers due to its wide usage in finding the solution of most of the real-life problems encountered in many areas such as engineering, economics, behavioral biology, missile guidance, etc. The study of differential game was founded by Rufus Isaacs (Vajda, 1967), in which "the homicidal chauffeur game" is among what were analyzed then. (L. Berkovitz, 1974; L. D. Berkovitz, 1967; Pontryagin, 1988; Rikhsiev, 1989; Subbotin & Chentsov, 1981; Vajda, 1967) give the basic principles of differential games.

There are many classifications of differential game problems in literature, among which is what is known as the pursuit-evasion differential game. This type of the differential game consists of two players which have a contradictory aim, the players are called evader and pursuer. The pursuer's aim is to finish the game in a finite time, while the evader's aim is to prolong the time of the game. These strategies are useful in many areas, such as coastguard saving shipwrecked sailors, missile launched at enemy aircraft, etc. Differential games that consist of more than one pursuer with geometrical and integral constrained were studied in (Azamov & Samatov, 2000; Garcia et al., 2021; Grinikh & Petrosyan, 2021; G. Ibragimov et al., 2018; G. I. Ibragimov, 2003, 2005; G. I. Ibragimov et al., 2011, 2012; Leong & Ibragimov, 2008; Subbotin & Chentsov, 1981).

In this paper, we study the use of differential game method in a multi-robots cooperative hunting game, in which two of the robots $(R_1$ and R_2) were the pursuers and the other robot (E) prey was an evader. The main objective of this game is to have the condition in which the two of the pursuers can catch the evader at the same time or if one of the pursuers catch it first, then it will wait until the other pursuer cooperate within a specified period of time otherwise if the time limit elapses a fresh searching will start. We were able to mathematically represent the problem by forming an ordinary differential equation and also, we analyzed the equations by showing and proving the all the condition needed to stop/end the game. All the necessary conditions to be satisfied in the game was given and proved.

2. Formulation of the problem

For this study, the multi-robot system comprises of similar robots interrelated together and working with each other towards the same objective. These robots are designated as P_1 and P_2 that is the pursuers, which are pursuing a single robot prey (the evader) E . In multi robot system the most challenging task is the cooperative pursuit this is because the accomplishment of this task has implications in the behavior of multi-robot collaborations.

2.1 Hunting method

The method of hunting consists of the following behaviors namely: searching, following, and surrounding. The pursuer team consists of 1-robot team and 2-robots team. At first, the pursuers $(R_1$ and $R_2)$ will be searching the evader (E) by the use of searching devices or sensors, this stage is called searching. Secondly if the evader (E) come into region of detecting, then the pursuer robots $(R_1 \text{ and } R_2)$ will use their tracking algorithms to follow it, this stage is called following. The pursuers (R_1 and R_2) will surround the evader (E) whenever it is possible by moving to the immediate surroundings of the evader, this stage is called surrounding. This will continuously be repeated until the evader is captured.

Once a single pursuer sees the evader, it will follow it, making 1-robot team and it will then wait for the other robot pursuer to cooperate. If the other pursuer is unable to detect the 1-robot team within a specified period of time, then the robot pursuer that made that 1-robot team will give up the target and start searching for another evader randomly. While if the other pursuer robot is able to detect that same evader with 1-robot team, then the team will change to 2-robots team.

2.2 Mathematical formulation of the problem

Let assume that the simple motion dynamics and constant speed of the robots E , R_1 and R_2 were given as S_E , S_{R_1} and S_{R_2} respectively. And also, the controls of E, R_1 and R_2 were given as their respective instantaneous headings ϕ , Ψ_1 , and Ψ_2 . Then, we can defined the states of E, R_1 and R_2 using their respective Cartesian coordinates for realistic plane as: $X_E = (x_E, y_E)$, $X_{R_1} = (x_{R_1}, y_{R_1})$ and $X_{R_2} = (x_{R_2}, y_{R_2})$ respectively. Therefore, we can say that the complete hunting state can be given as: $X = (x_E, y_E, x_{R_1}, y_{R_1}, x_{R_2}, y_{R_2}) \in \mathbb{R}^6$.

Since R_1 and R_2 can affect the state of the hunting by simply selecting states from their instantaneous respective headings Ψ_1 , and Ψ_2 , then our control variables of the pursuers and evader are their instantaneous heading angles, given as: $U_R = {\Psi_1, \Psi_2}$ and $U_E = {\phi}$ respectively. In the realistic plane $\dot{X} = f(x, U_R, U_E)$ the following ordinary differential equations system gives the normalized dynamics:

Where, $\beta_1 = \frac{S_{R_1}}{S_R}$ $\frac{S_{R_1}}{S_E} > 1$ and $\beta_2 = \frac{S_{R_2}}{S_E}$ $\frac{\pi R_2}{S_E} > 1$ are the normalized speeds for the two pursuers (robots) (note: their values may differ)

If the initial state can be given as:

Then, the hunting (game) ends at $t = t_f$ which corresponds to the state of the system that satisfies one of the following:

Since the pursuers are trying to shorten the capture time, and at the same, the evader is trying to prolong time the capture time, hence the performance function will be:

3. Analysis of the hunting (game)

Here, we give our co-states as follows:

This implies that, the robots' optimal trajectories are straight lines, because all the co-states and the optimal control inputs are constants.

Since our concern in this research is the termination condition in 2 (iii) above, that is a case where both robot $1(R_1)$ and robot $2(R_2)$ capture the evader (E) , then we have the following conditions to be satisfied simultaneously, i.e.

Since $\beta_1, \beta_2 > 1$ there exist unique solutions $\Psi_1 \& \Psi_2$ for $\phi \in [0, 2\pi]$. In the case when $t_{f1} = t_{f2} = 0$, that is $r_1 = r_2 = 0$, the evader has been captured by bot h robot 1 (R_1) and robot 2 (R_2) and the game (hunting) is over.

In this situation the triple (ϕ , Ψ_1 , Ψ_2) which satisfies (9) & (10) simultaneously with $t_{f1} = t_{f2}$ will be gotten by using the point where the two Apollonius circles meet. The circles are based on r_{10} with speed ratio β_1 and r_{20} with speed ratio β_2 respectively. The center of the circles between $E \&R_1$ and $E \&R_2$ is at distance

The point of intersection of the two circles guarantees simultaneous interception by both robots $(R_1 \& R_2)$. Hence for this capture, we have:

4. Conclusion

Two robots hunting game was discussed and analysed by the use of differential game method. The robot collective behaviours' evolutions represent the transition between distinct states of robots. The method partitioned the state space in to three distinct regions. The two robots hunting game consists of two pursuer robots and a single evader robot. The game ended when the two pursuers catch the evader simultaneously, ordinary differential equation was used to represent and analyzed the system. All the necessary and required condition was mathematically shown and proved and also the solution when the two robots (pursuers) capture the evader robot was provided.
