It is hoped that this need can be effectively facilitated by adopting the benefits of cloud computing through innovative research approaches.

The concept of computing in the cloud is about the delivery of IT services that run in a web browser; the type of services ranges from adaptations of familiar tools such as email and personal finance to new offerings such as virtual worlds and social networks. Storage of digital data is an important service among these. Cloud computing is a computing platform that resides in a service provider's large data centre Nelson (2019), and is able to dynamically provide servers the ability to address a wide range of needs of clients. The cloud is a metaphor for the internet. Some people call it the World Wide Computer. Technically, it is a computing paradigm in which tasks are assigned to a combination of connections, software and services accessed over a network Sedaghat (2018). This network of servers and connections is collectively known as the Cloud. Computing at the scale of the cloud allows users to access supercomputer-level power. Instead of operating their own data centers, firms might rent computing power and storage capacity from a service provider, paying only for what they use, as they do with electricity or water. This paradigm has also been referred to as "utility computing," in which computing capacity is treated like any other metered utility service—one pays only for what one uses Beizer (2018).

According to Standard and Quality Assurance in Education of the National Education and Amendments, it said there shall be a system of educational quality assurance to ensure improvement educational quality and standards at all levels, Qualification Framework for Higher Education was prepared to be used as guidelines to improve and develop curriculums, administration of education in order to produce qualified graduates to the society. Tertiary education institutions aim to improve the quality of education by using ICT and Ministry of Information and Communication Technology has defined Smart Nigeria 2020 Strategy as Fig. 1 to prepare readiness for dynamic development in order to compete with other countries in the region and become the ICT leader in 2020.

2. Background of Related Fundamental Concepts

This section reviews background concepts of different cloud computing resources. Authors in Liao, Li, Sultan and Zhang (2010) outlined related works on cloud computing resources with issues that are peculiar to each method. The rapid advancement of information technologies (IT) has contributed to the downward trend of the cost of computing resources. While prices of computing resources keep slumping, the technologies that depend on these resources are becoming more powerful, sophisticated and ubiquitously available than ever before. This advancements in network and Internet technologies have led to a computing model known in as cloud computing Schubert (2018). The model enables services providers known as Cloud Service Providers (CSPs) to provide computing resources as utilities through the Internet to Cloud Service Consumers (CSCs). Cloud computing is defined as a model for enabling convenient, on-demand network access to a shared pool of configurable computing resources (e.g. networks, servers, storage, applications, and services) that can be rapidly provisioned and released with minimal management effort or service provider interaction Herhalt (2019). The three most



common cloud services are Software-as-a-Service (SaaS), Platform-as-a-Service (PaaS) and Infrastructure-as-a-Service (IaaS). The model is also described by how it is deployed. The most popular among them are private, community, hybrid and public clouds.

2.1 ICT Shift Education

This complements method and techniques through which artificial shift systems can be implemented and employed in a reasonable way for practical applications. This is to raise the quality of Nigerian education by using ICT wisely and efficiently in order to develop the education and produce potential human resources through mobile computer and interactive instruction (Iyer, 2010).




Fig. 2 Conceptual Framework of Cloud Integration

2.3 Cloud Computing: Issues and Challenges

Although many formal definitions have been proposed in both academia and industry, the one provided by U.S. NIST (National Institute of Standards and Technology, 2019) appears to include key common elements widely used in the Cloud Computing community:

Cloud computing is a model for enabling convenient, on demand network access to a shared pool of configurable computing resources (e.g., networks, servers, storage, applications, and services) that can be rapidly provisioned and released with minimal management effort or service provider interaction Martins (2019). This definition includes cloud architectures, security, and deployment strategies. In particular, five essential elements of cloud computing are clearly articulated: On-demand self-service: A consumer with an instantaneous need at a particular timeslot can avail computing resources (such as CPU time, network storage, software use, and so forth) in an automatic (i.e. convenient, self-serve) fashion without resorting to human interactions with providers of these resources. Broad network access: These computing resources are delivered over the network (e.g. Internet) and used by various client applications with heterogeneous platforms (such as mobile phones, laptops, and PDAs) situated at a consumer's site. Resource pooling. A cloud service provider's computing resources are 'pooled' together in an effort to serve multiple consumers using either the multi-tenancy or the virtualization model, "with different physical and virtual resources dynamically assigned and reassigned according to consumer demand" Joshi (2018). The motivation for setting up such a pool-based computing paradigm lies in two important factors:



economies of scale and specialization. The result of a pool-based model is that physical computing resources become 'invisible' to consumers, who in general do not have control or knowledge over the location, formation, and originalities of these resources (e.g. database, CPU, etc.) . For example, consumers are not able to tell where their data is going to be stored in the Cloud. Rapid elasticity. For consumers, computing resources become immediate rather than persistent: there are no up-front commitment and contract as they can use them to scale up whenever they want, and release them once they finish to scale down. Moreover, resources provisioning appears to be infinite to them, the consumption can rapidly rise in order to meet peak requirement at any time. Measured Service. Although computing resources are pooled and shared by multiple consumers (i.e. multi-tenancy), the cloud infrastructure is able to use appropriate mechanisms to measure the usage of these resources for each individual consumer through its metering capabilities.

Cloud computing is a mature and stable technology and tool for commoditizing computing resources. The "cloud first" drive is aimed at addressing the challenges of acquiring and deploying IT systems in the public sector and by SMEs that provide IT enabled services to the government. Even though IT systems of some Federal Public Institutions (FPIs) have significantly advanced individually, some are still struggling to effectively digitize their operations due to lack of resources for acquiring and deploying appropriate computing resources. On the other hand, there is no deliberate plan or incentive by the government to ease business environment for local CSPs in Nigeria. Therefore, the Nigeria Cloud Computing Policy is to address the duo categories of challenges, National Information Technology Development Agency (NITDA), Nigeria Cloud Computing Policy, 2019

The specific challenges being experienced currently by majority of public institutions and SMEs, among others are:

- i. High cost of IT investments and poor sustainability of IT projects.
- ii. Shadow IT environment that is tough to manage, difficult to operate and nearly impossible to secure.
- iii. Inefficient and un-scalable IT environment.
- iv. Poor interoperability of IT systems and inability to effectively share information and IT resources.
- v. Highly competitive environment and lack of enabling business environment for local CSPs

2.4 Cloud Computing Policy: Key Facts

The Cloud Policy is hinged on the following facts:

- i. Implementation of the country's Economic Recovery and Growth Plan (ERGP) cannot be achieved without efficient deployment of computing and digital resources. Specifically, the ERGP recognizes the need to promote digital-led growth by ensuring there is increased contribution of ICT and ICT-enabled activities to GDP through significant expansion of broad band, increase in e-government and establishment of ICT clusters. Cloud computing in Public institutions and SMEs that provide service to the government can leverage cloud to enhance digital-led growth.
- ii. Understanding the value that cloud computing can have in enabling efficiency, transparency, and security of public sector information and communication technology operations, in line with the spirit of the National Digital Agenda 2020, the National ICT Policy and the National Cyber security Strategy; iii. The Federal Government is promoting Open Data Initiative aimed at ensuring substantial amount of public data is released for transparency purpose and creation of innovative digital services that will add value to the country socio-economic development. The best and fundamental technology to promoting Open Data is Cloud adoption.
- iv. The need to lower business or market entrance barrier for SMEs by creating an enabling environment for them to safely adopt cloud computing. This ensures there is considerable reduction in capital cost due to the need to pay upfront costs for IT infrastructure including hardware, software and associated maintenance, National Information Technology Development Agency (NITDA), Nigeria Cloud Computing Policy, 2019

3. Background of Cloud Computing Resources

Cloud computing was first born in Google, in the cloud computing research and application, to the analysis of its revolutionary impact on information industry and IT industry, focusing on the connection between software trade development and cloud computing. Proposed cloud computing healthy development definitely makes the software trade to change from the pure SaaS model to PaaS/IaaS, software on demand is the mainstream in the future (Sangnapaboworn, 2010).

3.1 Current cloud computing research and applications

Cloud computing is a relative new concept, although have not formed a unified definition, but the domestic and foreign scholars, universities, venders, government organizations from different angles are investing in research around the topic of cloud computing. The basic meanings as follow: A form of standardized IT-based capability—such as Internet-based services, software, or IT infrastructure — offered by a service provider that is accessible via Internet protocols from any computer, is always available and scales automatically to adjust to demand, is either pay-per-use or advertising-based, has Web-Cloud computing is to provide the applications of the previous hardware and software that require investment and technical capacity Web-based services to users; cloud computing means outsourcing, how much to buy cloud computing services relies on how much it is needed; Cloud is a huge resource pool, you pay-per-demand, cloud is virtualization, cloud can pay the same way as running water, electricity, gas, (Liao, Li, and Zhang, 2010).

3.1.1 Cloud Computing Layers

Cloud computing providers offer their services according to several fundamental models: infrastructure as a service (IaaS), platform as a service (PaaS), and software as a service (SaaS) where IaaS is the most basic and each higher model abstracts from the details of the lower models. Cloud Computing Layers consisted of IaaS, PaaS and SaaS can be seen in Fig. 2.

Infrastructure as a service (IaaS) In the most basic cloud-service model, providers of IaaS offer computers – physical or (more often) virtual machines – and other resources. IaaS clouds often offer additional resources such as a virtual-machine disk image library, raw (block) and file-based storage, firewalls, load balancers, IP addresses, virtual local area networks (VLANs), and software bundles. To deploy their applications, cloud users install operating-system images and their application software on the cloud infrastructure (Sultan, 2010).



3.1.2 Platform as a service (PaaS)

In the PaaS models, cloud providers deliver a computing platform, typically including operating system, programming language execution environment, database, and web server. Application developers can develop and run their software solutions on a cloud platform without the cost and complexity of buying and managing the underlying hardware and software layers (Henderson, 2010).

3.1.3 Software as a service (SaaS)

In the SaaS model, cloud providers install and operate application software in the cloud and cloud users access the software from cloud clients. This eliminates the need to install and run the application on the cloud user's own computers, which simplifies maintenance and support (Chen, 2011).




Fig. 4 Cloud computing layers

3.1.4 Cloud clients

Users access cloud computing using networked client devices, such as desktop computers, laptops, tablets and Smartphone. Some of these devices – cloud clients – rely on cloud computing for all or a majority of their applications so as to be essentially useless without it (Zhang, 2010). Examples are thin clients and the browser-based Chrome book. Many cloud applications do not require specific software on the client and instead use a web browser to interact with the cloud application. With Ajax and HTML5 these Web user interfaces can achieve a similar, or even better, look and feel to native applications. Some cloud applications, however, support specific client software dedicated to these applications (Li, 2010).

4.0 Review of Related Literatures

A research was conducted titled "Implementation of Cloud Computing in Education – A Revolution". It said that the cloud computing was used in the education about teaching, flexibility and expenses for fundamental structures as Fig. 3. The benefits and limitations of cloud computing are also mentioned in the research. According to the findings, a lot of tertiary institutions improved the fundamental structures of IT and data. The challenges could be solved by using cloud computing (Henderson, 2010). The challenges included expenses, flexibility, access to information and technology. Using cloud computing technology in the institutions, neediness should be defined and the privacy identification and cloud services are as follows:

It eliminates the need to install and run the application on customer own computer and simplifying maintenance and support.




Fig. 5 University using the services of cloud computing
